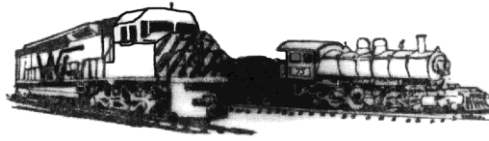

We have scheduled this event for Sunday, October 9<sup>th</sup> 2022. We continue to hold this event at the Washington County Fair Park in the Ziegler Family Expo Center. The Washington County Fair Park is located minutes from Milwaukee at 3000 Pleasant Valley Road (Hwy PV), West Bend, WI 53095. The park is visible from US Highway 45 and there is a ramp for County Highway PV. The event will run from 9:00 a.m. to 3:00 p.m. Dealers and exhibitors may begin set-up at 7:30 a.m. There is easy access to the facility, including a garage door entrance on the side, as well as plenty of parking.
